Introduction

The educational websites of today are excellent examples of how both technology and education collide for the user. Educational websites allow for the designer to create an environment that personalizes the learning for its intended audience. Educational websites can allow ease of access for its intended audience and can provide a valuable interactive learning experience. Unlike with most other websites the goals and objectives of the educational website are particularly important. It is important to take a holistic non-biased view at educational websites to ensure that they meet the goals and objectives they set out to accomplish for their learners and intended audience. The human user interface plays a vital role in linking the user to the goals and objectives for the website. The ability to evaluate or judge each website will be critical to ensuring those objectives and goals and methods to achieve them through human user interface are being met. According to Potter (n.d). "evaluation is one of the most important steps in the design process, and yet it's usually the step that gets left out." (Lesson 10, para 3.) For this project I intend to provide a holistic professional evaluation of the human user interfaces and how they move to meet the websites goals and objectives with the following two selected educational websites:

Both websites are similar in their purpose and scope and have some differences in concepts, platform, interface, and design that I will discuss later in this project. First, the educational website funbrain according to its platform was formed in 1997 and has a target audience of learners in Kindergarten through 5th grade. In addition, this website has a secondary audience that aims to support the parents and educators for this domain of learners. Fun brain has numerous games, books, comics, and video to choose from for its students. These resources help the students with critical thinking, problem-solving and reading skills. The second website discussed in this report is the educational website turtle diary that has a target audience of learners in Kindergarten through 8th grade. Like funbrain, turtlediary also has a secondary target audience of both the parents and educators of these intended learners. Turtle diary provides a variety of educational resources for its learners in content practice, problem-solving skills, and fun educational interactive experiences. In addition, turtle diary also aims to

help reduce stress for parents of online students, provide resources, encourages educational gaming that corresponds with learning, and provides learner assessments for both parents and educators.

In comparison both educational websites contain an enormous amount of content for numerous grade levels of learners. In this project I will narrow my focus to comparing, contrasting, and evaluating the third-grade level for each website. The purpose of me narrowing the project will allow a more manageable and qualitative project presentation for the reader. There are many different tools available for website evaluation but for the purpose of this project, I aim to use just one type of rating form.

Website Rating Instrument

The instrument that I will use for the purpose of evaluating the above mentioned two educational websites during this project is a website rating form created by Dr. Tom Reeves (*Harmon & Reeves 1998*©). This tool can be found by following the below link:

According to the Harmon & Reeves evaluation instrument (1998, para. 1) “This instrument is meant to be used by teachers (pre-service or In-service) to evaluate Web sites that they might use for teaching and learning purposes with their students.” The evaluation instrument uses a five-point scale, and the designed sub-questions are provided to help the evaluator in the critical thinking needed to provide the educational website with a successful evaluation.

I was given permission to use this website rating instrument via Syracuse University in course IDE- 641 for the purpose of this project. Within this project, I Kevin Schuller will modify the instrument to the proper application of evaluation for my selected websites. The modification of this educational website evaluation instrument will be applied to my two chosen educational websites (funbrain.com, turtlediary.com) to meet the requirements outlined in the rubric for my course of instruction. The modification will include removing any non-applicable criteria within the evaluation instrument to meet the needs of my two selected educational websites. In addition, there will be some additions made to the evaluation instrument based on resources and information provided within my course.

The purpose of the detailed evaluations provided below will help capture a deeper understanding of these two interactive websites. - The educational website cannot be used with a variety of browsers to include (internet explorer, safari, google chrome, etc.) Modern browsers pose a serious issue.

- This educational website had no software restrictions minus the previously stated browser issues on various platforms.
- This site is free for the user and that contributes to its popularity on the web. The paid site provides a richer experience as a steep cost to the user.

Evaluation Comments:

- There is no information requirement of free users but there is of paid users.
- There is a clear disclosure and explanation for "cookies" within the website.
- The terms and conditions are clearly spelled out for copyright violations of users. The paid site requires parent interactions, but the free site does not.
- The terms and conditions do not require user acknowledgement within website for free users, but it is required for paid users.
- All liabilities for both the user and website are defined within the terms and conditions.

Compare and Contrast

The results within this evaluation indicated a stark difference between the two educational websites. The evaluation of these similar educational websites (*although designed for the same basic purpose and content*) were on the opposite sides of the spectrum. The goal and objectives of both educational websites look at providing students in the 3rd grade with innovative technology to make learning both fun and educational. One of these websites proved to be far superior to the other for several different reasons.

Funbrain is an extremely popular free educational website that lacks a bit of accuracy within its content and design. The literature side works well for providing a wide variety of books aimed at making reading appealing to the user. The educational games that are contained within this site are entertaining for the learner, but it does not seem to effectively challenge the cognitive domain for its user. Some games provide entertainment but not educational value. Most of the videos contained within the 3rd grade section are nothing more than cartoons you would see on television. The videos also lacked good structured and efficient educational content. The overall content and its organization contained within the 3rd grade level category is bunched together with other grade levels. For example, you might find a game, video or book that is designed for a user that is in grades Kindergarten through 5th grade. This can be problematic as it lacks specific cognitive learning theories for a specific grade level. The category becomes too broad and misses on the intended goals and objectives for learning at a particular grade level. I found navigation within the site exceedingly difficult as the use of ads (due to it being a free site) that severely detracts and distracts the user from the learning experience. On many occasions it is difficult to focus on the lesson, game, or book because ads are visually distracting you from the content and the learning content appears in a small box within the larger website. In some applications you can make the content bigger to help with learner focus, but the ads never really disappear. Although there are numerous activities they do not seem to nest and rely on past concrete experiences to aid in cognitive growth. Information is organized poorly and is not presented in a professional manner that would lead the user down an educational path. The graphics and media within the site lack depth and richness and seem very generic in nature. This also takes away from the appeal and reliability of the educational environment that the website is designed for. I do not think this website has an overall good web design because the user has a difficult time searching for information or getting help within the website. Overall, the site lacks balance, richness, structure, and navigation. The site did work as intended and had little technical functionality issues. This functionality made this website reliable on every occasion I visited it. The ease of access for this site because of the cost is ultimately why I believe this is such a popular site. Parents and teachers with users that visit this site should understand the lack of effective and efficient educational content compared to other sites that are on the web. Funbrain has a good foundation but needs improvement and adjustments to more educational effective and efficient content and less entertainment.

To do this, I believe that it might incur cost and ultimately move this website away from being able to provide its service for free. There is some validity to the old saying in *you get what you pay for* in this educational website.

Turtle diary is an extraordinarily versatile website that can cater to free and paid users. The experience for paid users is much more extensive but the free users still have a particularly good educational experience. The information within the website is extremely accurate and the website itself boasts numerous awards and achievements. The cost of a membership to this site can be expensive for some users. The information and content within the site are kept current and up to date daily. There is an impressive amount of content and a wide variety of topics available to all users within the site. This site is different than fun brain in that it also offers assessments, exams, lesson plans, quizzes, tools for teachers, printable worksheets, biographies and much more. The additional educational resources really add to the capabilities of the learner environment and set it apart from fun brain. Turtle diary is unlike fun brain in that it provides more of a focus on education versus entertainment. Turtle diary is clearly committed to its efforts to make education as its foundation. There are in fact fun interactive games that provide entertainment but there is also educational substance and structure within the 3rd grade section. The lessons, educational material, resources, and information are specifically geared to the age of its intended learner. The educational material is challenging and provides a level of effectiveness and efficiency that is relevant to its user. The educational material really helps aid in cognitive growth and builds on previous concrete experiences for each user. There are a few distractions on the free side of the site due to ads, but the overall professional structure of the site looks to reduce that as much as possible. Navigation of this site is much easier than that of fun brain and there are far fewer times that I found myself out of the desired content area. Searching for material within the site can be a bit challenging as it searches the web holistically. The search engine within the website links the search results to those based on the entire web and not just the site. When using the search engine, if the user is not careful, can be easily diverted to other unintended websites. The frequently asked questions, site map, and contact areas of the website really aid in any help or navigation challenges within the website. The organization, structure, and media efficiency are also a positive takeaway for this website. Better use of audio features could help enhance the experience. The media games and content provide entertainment but also maintain a professional educational experience. Turtle diary has extraordinary organization and structure that cater to different learning styles and clearly identify goals and objectives. The 3rd grade section of the site exemplifies good web design. The graphics, color choice, layout and text selection provide excellent balance, topography, white space useability, and structure to the educational website. The website is reliable and worked every time it was visited. Overall, the website is popular but costly to the paid user. To utilize all the benefits of the site you pay a significant amount of money. That cost could sway some potential users as not everyone has the monetary ability to reap all the benefits of the website.

Still the free user gets to experience a lot of valuable educational content and use some of the great benefits this site has to offer.

In the end and based on the results of my evaluation I feel Turtle Diary is a far better educational website than Fun Brain. I have come to this conclusion due to the design, scope, goals, and objectives of what each site is intended for. Simply put Fun Brain seems to rely more on its free entertainment value versus Turtle Diary's solid educational foundation. Some of the increased qualitative educational content within Turtle Diary is due to the ability to apply the money it earns into the design, content, and resources of the website. Fun Brain has more of an entertainment aura around it and it seems that educational content comes in as a second priority. Turtle Diary is also far better catered to the parents and teachers of its learners as it provides far more assessment tools and resources for education. Unlike Fun Brain there is a clear priority of education as a main priority and the entertainment aspect as a second. Both educational websites provide a positive experience with clearly delineated strengths and weaknesses. The decision as to which website to use will depend on the monetary resources the user wants to dedicate and the goals and objectives in which each learner is visiting the educational website for.

Evaluation Process Summary

The utilization of the Dr. Tom Reeves (*Harmon & Reeves 1998*©) educational website evaluation instrument was a very eye opening and informative experience. Website evaluation looks to focus on a particular target and in this case, it was the educational website. In this evaluation the twelve subject areas and sub questions were quite challenging for me. Evaluation involves judgement and this evaluation was not an exception. The answers to many of these questions are very subjective in nature and I tried to format my answers based on as much detailed analysis and data collection that I could. My natural tendency during this evaluation was to try to find an objective way to measure my results and I very much struggled with the subjective nature of my answers. To be as accurate as I could with my subsection, this evaluation instrument needed to be slightly modified to fit the needs of my two educational websites. I found that in my evaluation there was only some minor removing, adding, and adjusting of the questions. In my mind this evaluation instrument hit the mark by providing me with the right information to expertly evaluate the two educational websites.

Conclusion

The judgement of the evaluation process in these two websites was much more difficult for me than I anticipated. It was extremely difficult for me after my readings and course instruction to practically apply all the information I learned about evaluations to this project. The subjective nature and judgement of any evaluation does not necessarily equate to an effective one. Not all websites are created equally, and many do not contain accurate and reliable information that nests with the intended goals and objectives. The ability to evaluate these websites properly should start with clearly

defined objectives for your evaluation, identifying proper balance within the website, and producing a judgement on the information contained within. The goal of this evaluation produced within this report theoretically would lead to improvements within the site and increase the student's efficiency and effectiveness in learning. In addition, this evaluation would help the website owners to improve an already existing product to determine its effectiveness, efficiency, merit, and value. I have learned that the evaluation process whether formative or summative takes practice to master. I have discovered valuable lessons during this project on evaluations that I will be able to use in future evaluations. I have a long ways to go before I become a proficient evaluator, but this project really helped me to be able to utilize some practical application to many evaluations as an instructional designer in the future.
